WILL ENSURE THAT WITH THESE EXCHANGES THE EUROPEAN NORMS OF THE AVG WILL BE APPLIED. YOU CAN UNSUBSCRIBE FROM THESE EXCHANGES/MESSAGES AT ANY TIME.

2) THE PASSING ON AND RECEIVING PERSONAL DATA OUTSIDE OF CHUPITOS BEHEER B.V.:

THE PURPOSE OF PROCESSING YOUR PERSONAL DATA CAN ENTAIL THAT CHUPITOS BEHEER B.V. SHARES PERSONAL DATA WITH OTHER ORGANISATIONS.
